# What is Title I?

West Side Elementary is identified as a Title I school as part of the Elementary and Secondary Education Act of 1965 (ESEA). Title I is designed to support State and local school reform efforts tied to challenging State academic standards in order to reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title I schools must jointly develop with all parents a written parental involvement policy.

# **School Plan for Shared Student Achievement**

What is it? This is a plan that describes how West Side Elementary will provide opportunities to improve parent engagement to support student learning. West Side Elementary values the contributions and involvement of parents in order to establish an equal partnership for the common goal of improving student achievement. This plan describes the different ways that West Side will support parent engagement and how parents can help plan and participate in activities and events to promote student learning at school and at home.

How is it developed? West Side Elementary School welcomes parent input and comments at any time regarding the plan. All parent feedback will be used to revise the plan for next year. We also distribute an annual survey to ask parents for their suggestions on the plan and the use of funds for parent and family engagement. Parents can also give feedback at any time in our Family Resource Center, school office, or any family engagement activity.

Who is it for? All families are encouraged and invited to fully participate in the opportunities described in this plan. West Side will provide full opportunity for the participation of parents with limited English, parents with disabilities and parents of migratory children.

Where is it available? The plan is available at all Title I meetings and at wse.catoosa.kl2.ga.us. Parents can also get a copy of the plan in the Family Resource Center.



# **Goals for Student Learning**

#### District Goal:

\*To improve the percentage of students scoring proficient - meeting or exceeding standards - in grades 3,5 and 8 on the first administration of the end of grade assessment in all academic areas.

#### School Gos

\*Increase the percentage of students who are proficient or above in Milestones Test in math by 3%.

\*Increase the percentage of students who are proficient or above in Milestones Test in reading/English language arts by 3%.

\*Increase the percentage of students who are proficient or above in Milestones Test in science by 3%.

# **Reaching Out**

West Side Elementary recognizes that parents are children's first educational partners. West Side Elementary wants to increase teachers' roles as educational partners with parents. To this aim, it will be necessary to meet with parents regularly to get suggestions in the decision-making process. To accomplish this end, staff will be trained to:

- Coordinate better with parents in order for two-way communication to take place.
- Embrace the value and utility of contributions of parents.
- Reach out to parents.
- Work with parents as equal partners.
- Implement and coordinate parent programs.
- Build ties between home and school.

In order to be as seamless as possible, West Side Elementary will coordinate and integrate parent involvement endeavors with as many other agencies as These include Homeless, ESID, Head Start, migrant programs, Pre-K. Parents as Teachers, etc. All programs and information will be sensitive to the needs of with disabilities and limited reading abilities. This coordination is to be extended to community-based organizations and businesses by developing roles for play in the education of students and parents.



As parents become full partners in their children's education. West Side Elementary will conduct activities as appropriate with the center of these being the Resource Center where parents and community members can meet and be a part of volunteer activities for family and community.

West Side Elementary staff and parents jointly developed this policy and its sister document (the school-parent compact that outlines how parents and school will be responsible for supporting student learning) and subsequently reviews/revises these documents at least yearly.

The West Side Elementary School-Parent Compact outlines how:

- School will provide high-quality curriculum and instruction in a supportive and effective learning environment that enables children served under Title I
  to meet the State's standards.
- Each parent will be responsible for supporting his/her children's learning.
- Conferences are to be held in which the compact pledges are discussed.



## Family-School Compacts

As part of this plan, West Side Elementary and our families will develop a school-parent compact, which is an agreement that parents, teachers, and students will develop together that explains how parents and teachers will work tagether to make sure all our students reach grade devel standards. The compacts will be reviewed at all parent meetings and updated annually based on feedback from parents, students and community. Listing this injust the School and Parent Advisory Douncils will revise the compact. School parent compacts are kept at home and at school.

## Parent Involvement Program & Activities

The West Side Parent Involvement Policy/Plan will be distributed at every possible venue such as open house, orientations, community events, PTO meetings, parent meetings, school website, front desk, etc. These actions are at the heart of this policy which ultimately aspires to increase student achievement.

Meetings will be scheduled at flexible times so that participating parents are able to attend without barriers. At all meetings, especially the Annual Title I meeting, Title I requirements, schoolwide components, and parents' rights to be involved will be explained. Parents will be involved in the planning, reviewing and improvement of programs under Title I. These include, but are not limited to, the parental involvement policy, compact and the schoolwide program plan.

## **Parental Involvement**

West Side believes that parent involvement mean the participation of parents in regular two-way, and meaningful communication involving student academic learning and other school activities, including ensuring:

- That parents play an integral role in assisting their child's learning.

- That parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child.

## Parent & Family Engagement Program and Activities

Opportunities for parents to formulate suggestions, share experiences with other parent and participate, as appropriate, in decisions relating to the education of their children. These opportunities are made available throughout the school year at the parent meetings and/or workshops. Parents are encouraged to share ideas and participate in discussions. Each month has opportunities for parent contact.

Responses to parent suggestions: Parents evaluate each parent workshop. Parents are encouraged to make suggestions for improvement. When necessary, immediate action is taken on certain suggestions after consulting with the Title I Coordinator and school administrators. Any unsatisfactory parent comments are collected and acted upon by the Title I Coordinator and school administrators.

Parent meetings are offered throughout the school year on a variety of topics and at various times of the day to maximize parent participation. Notification will be done through a variety of media including newsletters, home visits, marquee, etc. Attempts twill be made to eliminate barriers to parent involvement such as transportation and translation/interpretation needs. Training activities are intended to enable parents to work with their children to improve achievement.

### Parent & Family Engagement Program and Curriculum

West Side seeks to unite parents and increase parental participation in student education. Of particular note, Title I funds may be used for transportation or home visits to remove barriers. It is our goal that the Title I program continues to serve and improve all programs. It is our desire for all parties to be well-informed. Some of the things we will confer about are:

- \* Milestones scores, report cards and progress reports.
- Student assessments/interpreting tests.
- Student curriculum, standards and assessments.
- Parents' suggestions and complaints with subsequent discussions with the Parent Involvement Coordinator.
- Monitoring student progress.
- Training opportunities.
- \* Results of annual school review including school performance profiles with school status.
- \* Literacy training and using technology to help parents improve their children's achievement.
- \* Yearly and ongoing evaluation of parent involvement initiates.
- Parents gaining access to staff.
- \* Opportunities for parents to participate in their children's classes and observations scheduled with the teacher.
- \* Other reasonable support for parent involvement activities as parents may request.

#### **Keeping Parents Informed**

West Side Elementary seeks to ensure that all information related to school and parent programs, meeting, and other activities is written in languages parents can understand. When needed, every attempt will be made to translate, interpret and maintain readability. The monthly newsletter, policies, and compacts are regularly translated. The Home & School Connection is provided to Spanish speaking families.

<u>School Programs</u> - Information is discussed throughout the school year. Teachers, administrators, and the academic coach remind parents of the various school programs available for their children.

Results of the annual school review (including school performance profiles) - School administrators are responsible for reporting this information to parents. This is done through the newspaper, website and status letter. Results of the spring Title I survey are shared with the spring Title I Parent Advisory Council and WSE School Council.

<u>Opportunities to Volunteer</u> - Parents are invited to volunteer at West Side Elementary. A short training is provided on September 17th at 8:30 AM. Volunteers will be tapped based on their strengths, talents and availability.

<u>School Newsletter Information</u> - A monthly school newsletter is distributed to parents and posted on the website. Timely information is highlighted in the newsletter such as upcoming meeting, school calendar, assessments, etc.



<u>School Marquee</u> - The school marquee is located at the front of the school and is updated regularly to serve as an effective reminder about upcoming events.
